


## LEGAL DESCRIPTION


THE SUBDIVISION TO BE KNOW AS "FREMONT TECHNOLOGY PARK", IS COMPOSED OF LOTS 2 THRU 8, AND TAX LOT 144 OF D. SCHROEDER'S SUBDIVISION, LOCATED IN THE NORTH ONE-HALF OF THE SOUTHWEST ONE-QUARTER LYING WEST OF THE CHICAGO AND NORTHWESTERN RAILWAY COMPANY'S RIGHT-OF-WAY, ALL IN SECTION 12, TOWNSHIP 17 NORTH, RANGE 8 EAST OF THE 6TH P.M., DODGE COUNTY NEBRASKA, EXCEPT EASEMENTS AND ROADS OF RECORD AND IS MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING FROM THE NORTHWEST CORNER OF THE SOUTHWEST QUARTER OF SAID SECTION 12, SAID POINT ALSO BEING THE POINT OF BEGINNING; THENCE ON AN ASSUMED BEARING OF NORTH 87 DEGREES 58 MINUTES 31 SECONDS EAST ALONG THE NORTH LINE OF SAID SOUTHWEST QUARTER, SAID LINE ALSO BEING THE NORTH LINE OF LOTS 1 THRU 7, D. SCHROEDER'S SUBDIVISION, A DISTANCE OF 2622.34 FEET TO THE NORTHEAST CORNER OF SAID SOUTHWEST QUARTER; THENCE NORTH 87 DEGREES 53 MINUTES 28 SECONDS EAST ALONG THE NORTH LINE OF LOT 8, D. SCHROEDER'S SUBDIVISION, A DISTANCE OF 330.08 FEET TO THE NORTHEAST CORNER OF SAID LOT 8; THENCE SOUTH 02 DEGREES 23 MINUTES 55 SECONDS EAST, ALONG THE EAST LINE OF SAID LOT 8, A DISTANCE OF 1287.07 FEET TO THE SOUTHEAST CORNER OF SAID LOT 8; THENCE SOUTH 88 DEGREES 00 MINUTES 22 SECONDS WEST, ALONG THE SOUTH LINE OF SAID LOT 8, A DISTANCE OF 330.02 FEET TO THE SOUTHWEST CORNER OF SAID LOT 8; THENCE SOUTH 87 DEGREES 57 MINUTES 07 SECONDS WEST, ALONG THE SOUTH LINE OF LOTS 7 THRU 1, D. SCHROEDER'S SUBDIVISION, A DISTANCE OF 2054.48 FEET TO A POINT; THENCE NORTH 02 DEGREES 26 MINUTES 20 SECONDS WEST, A DISTANCE OF 476.33 FEET TO A POINT; THENCE SOUTH 87 DEGREES 12 MINUTES 40 SECONDS WEST, A DISTANCE OF 567.00 FEET TO A POINT ON THE WEST LINE OF SAID SOUTHWEST QUARTER; THENCE NORTH 02 DEGREES 26 MINUTES 20 SECONDS WEST, ALONG THE WEST LINE OF SAID SOUTHWEST QUARTER, A DISTANCE OF 818.48 FEET TO THE POINT OF BEGINNING. SAID PARCEL CONTAINS A CALCULATED AREA OF 3,530,859 SQUARE FEET (81.06 ACRES) MORE OR LESS.

SAID EASEMENTS ARE RESERVED FOR THE USE OF PUBLIC UTILITIES, AND ARE SUBJECT TO THE PARAMOUNT RIGHT OF THE PUBLIC UTILITY TO INSTALL, REPAIR, REPLACE AND MAINTAIN ITS INSTALLATIONS.


